CHIEF FIRE MARSHAL'S REPORT

Chief Fire Marshal Chris Weniger reported the following:

- 1. Reminder to all Chiefs to let the Fire Safety Office know when BW Meters need calibration (every 6 months).
- 2. Update on Paging Issues: VHF antennas on Zion Mountain are to be replaced. Optimization of entire system is taking place in the next two weeks. Minitor 3 and 4 pagers are not narrow band capable. Will be conducting tests with a sampling of these pagers to see if this is part of the issue. Commissioner Catrombon, Jr. gave three pagers to County to run tests on them.
- 3. We are low on Class A Foam and need to purchase 20 pails of Class A Foam for Station 37 and stock. Total Cost would be \$2,580.00; this is the FXP Brand from Firefighters Equipment. A motion was made by Commissioner Nuara, seconded by Commissioner Catrombon, Jr. to purchase 20 pails of Class A Foam. Roll call vote: All approved.
- 4. The documentation of inventory for destruction continues, hopefully will be done by the end of this month.
- 5. We need to purchase glove and hoods have 3 pairs of small in inventory and the Fire Companies have about 3 pairs each. The cost of ½ dozen gloves is approximately \$40.00-\$60.00/pair. The cost of hoods is approximately \$40.00-\$60.00. Commissioner Nuara recommends ordering 30 sets of gloves. - 1. As discussed at the last Fire Operations Meeting, all Chief's need to make sure that everyone is structurally geared up and ready to go. Beards have to come off according to the OSHA regulation.
- 2. All drivers must have full Interior Firefighters gear.
- 3. Started counting all hours, not just firefighting hours, but drills, truck checks, all meetings, etc. We are trying to account for as many hours possible as it is better/injury for the Insurance Company.

Commissioner Vatter:

- Commissioner Vatter announced that the Commissioners agreed to start a Hillsborough District Signal 100 Team. They appointed Joann Bullock to Coordinate and head up the Team. She will be putting together a proposed plan and looking for volunteers. I provided a copy of the Somerset County Rehab GOG's and Joann will set up a meeting with Captain Gwin of the Hillsborough Rescue Squad to coordinate with their Rehab.

You have the right to ask them if they want to tell you what happened, they will need to get a letter from the doctor stating that they can come back to normal duties. This must be the doctor that treated them. I spoke with Brawlow, they cannot respond to calls unless they have a letter.

Chief Paterno of Station 37 submitted the following Proposal for Quartermaster Reimbursement:

Proposal for Quartermaster Reimbursement

The Hillsborough Township Board of Fire Commissioners has demonstrated that they are currently moving in a positive direction with regards to the efficiency of the Fire District. One way that they have accomplished this is with reimbursement of personnel in regards to the jobs that they perform. This is a positive approach as it insures that the necessary jobs be accomplished with diligence and accuracy. Currently, there is only one group of personnel that are not being compensated for their performance. This group is the Quartermasters. They perform a most necessary function for the Fire District. This job requires the entry of all Fire Activities. These records are paramount to the recordkeeping of personnel. This activity is recorded in hours per month, not minutes.

This proposal is to reimburse each Quartermaster the sum of \$500.00 per annum for their services. This reimbursement would be in addition to their respective pay-per-call. This would be added to this amount and subject to all compensation regulations.
