REGULAR MEETING

JUNE 13, 2017

The Board of Fire Commissioners of Hillsborough Township, County of Somerset, New Jersey convened in Regular Session on Tuesday, June 13, 2017 at 8:00 pm. at the Hillsborough Township Municipal Building on South Branch Road. Commissioner Chairman Charlie Nuara called the meeting to order.

Following the Pledge of Allegiance to the Flag, a call of the roll indicated that Board members present were: Commissioner Charlie Nuara,, Commissioner John Lazorchak, Commissioner Pat Buckley, and Commissioner Mike Carone. CHIEF FIRE MARSHAL’S REPORT

Chief Fire Marshal Chris Weniger reported the following:

1. Township Fireworks are scheduled for Saturday, July 1, 2017. Will send an email out when it gets closer.
2. Hose, ladder and pump testing is scheduled as follows: (Fire Marshal Giordano is handling this)

- Hose/Ladders: Station 36 – June 26, 2018
Station 37 – June 27, 2017
Station 38 – June 28, 2017
Station 48 – June 29, 2017
 - Pumps: Stations 36 & 48 – July 6, 2017 at Station 48
Stations 37 & 38 – July 7, 2017 at Station 38
3. SCBA Flow testing will be done sometime in July. Will provide dates.
 4. Rescue Truck repairs exceed \$30,000.00. Truck will be going out of service next week for approximately one month. Most tools repairs are complete. Remainder will be done this week. The Township will be paying for the repairs.
 5. Additional extrication equipment will cost \$2,750.00.
 6. Breathing air compressors will be installed next week at Stations 36, 37 & 38.
 7. Old engine 36 has been sold for around \$14,000.00.
 8. Finally received a check from the Depot Fire and has been deposited.
 9. Discussed requests for Station 37 at the Work Meeting. Provided the Commissioners with a list of inventory of extrication equipment. **A motion was made by Chief Fire Marshal Weniger, seconded by Commissioner Buckley to approve the purchases on the extrication equipment list. Roll call vote: All approved.**

Tools for Stations 36 and 38 have been divided so all 3 companies are set up adequately. There will be tools remaining for Station 48, but availability of a pump is unknown. There is an electric tool that is being serviced, once it is repaired, it can be given to Station 48. Station 48 still needs to get qualified on tool use and operations.

10. Would like to purchase 2 sawzalls for Station 36 and 1 for Station 38. Cost would be \$451.00 for a complete kit which includes tool, 2 batteries, and a charger. **A motion was made by Commissioner Nuara, seconded by Commissioner Buckley to purchase 3 sawzalls in the amount of \$451.00 each. Roll call vote: All approved.**

It was questioned whether Station 36's sawzall is compatible to the ones that are being purchased. This will be checked into and will discuss further at the July Work Meeting.
