FEBRUARY 14, 2017

Chief Fire Marshal Chris Weniger reported the following:

1. Station 37's old brush truck went out to bid. Bids opened on February 13, 2017 at 10:00 a.m. Received 4 bids, 2 for \$2,000.00, 1 for \$1,878.58 and 1 for \$990.00. Contacted Attorney Braslow regarding the bid quotes and he did some research and said it is completely up to the Board who they choose to offer the bid to. **A motion was made by Commissioner Nuara, seconded by Commissioner Buckley to offer the bid to Able Escamillia for \$2,000.00. Roll call vote: All approved with Commissioner Vatter abstaining.** Commissioner Nuara read Resolution 17-001 – Authorizing Disposal of Personal Property.

Resolution 17-001

Authorizing Disposal of Personal Property

WHEREAS, the Fire District is the owner of a 1989 Ford F350 Pick-Up Truck, 4x4; automatic transmission, 7.3 liter diesel, \$17,350 miles, Electric Winch (hereinafter referred to as "Truck") which is no longer needed for public use; and

WHEREAS, the Commissioners are desirous of selling said Truck in an "as is" condition without express or implied warranties.

NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District No. 1 in the Township of Hillsborough, County of Somerset, as follows:

(1) The above referenced Truck shall be advertised for sale with sealed bids to be received on or before Monday, February 13, 2017 at 10:00 a.m. at the Hillsborough Bureau of Fire Safety, 379 South Branch Road, Hillsborough, NJ 08844.

(2) The Truck shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of the Truck.

(3) All bidders must submit prior to removal of the Truck a certified, cashier's or bank check for the total amount of the bid submitted.

(4) The successful bidder must remove the Truck within 48 hours from the time of acceptance of said bid.

(5) The Truck may be inspected by contacting Chief Fire Marshal Christopher Weniger at (908) 369-4313.

(6) The Commissioners reserve the right to accept or reject any and all bids.

2. The new firewall and monitoring software was installed on the server. This completes the first phase of the computer upgrades.
3. The 2016 NJDFS audit is completed and was submitted to the State. Commissioner Nuara signed off on the audit.
4. All applications for the statewide credentialing system thru FEMA must be submitted to Fire Safety.
5. VHF repeater and simulcasting will begin in the near future. Waiting on the State pricing to be worked out. If it is higher than they accept, we may have to go out to bid.
6. The first phase of old records destruction is complete. We disposed of 41 boxes and have 10 boxes that still need destructed.
7. Would like to have the part time Fire Inspector to come in a day here and there (a couple days/month) if that is ok with the Board. The Board gave permission to utilize the part time Fire Inspector.
8. Would like to put the Skid Unit out to bid. The Board gave permission to do so.
9. Would like to do all the air system upgrades for breathing air. Station 37 will be first, pending approval of the Budget. Cost would be \$126,183.26. **A motion was made by Commissioner Buckley, seconded by Commissioner Catrombon, Jr. to approve the service upgrades, pending on approval of the budget. Roll call vote: All approved.**
10. Hose testing is done every July. We are currently using Fail Safe. Fire Marshal Giordano received 3 quotes, would like to continue to use Fail Safe. Quote was for a little over \$13,000.00 and locked in for 3 years. **A motion was by Commissioner Vatter, seconded by Commissioner Catrombon, Jr. to approve to use Fail Safe for approximately \$13,000.00, locked in for 3 years. Roll call vote: All approved.**
11. Station 36's old pumper remains in the warehouse. Have not received any good offers.
12. All old hose is sitting in the Firehouses. Manville Fire Company may be interested in some of the hose. Commissioner Nuara said to contact them and have them send a letter to the Board.
13. All old turnout gear is also sitting in the Firehouses. We need to decide what to do with it.

- Received the gear replacement list from Station 37.
- Gear is on this year's budget question to increase from \$60,000.00 to \$75,000.00 for 2017.
- Commissioner Carone will check into the gear inventory at Station 36. Chief Fire Marshal Weniger checked into the turnaround time for getting gear, it can be rented (3-5 day turn around) by the month or Academy class. Will give the cost of renting to the Board.

- Vehicles at Fire Scenes:

- Discussed the amount of vehicles that have been showing up at fire scenes. Chiefs need to look at how many vehicles are showing up at scenes. No personal vehicles should be at the

scene. Commissioner Nuara stated that they need to cut the Lieutenants from coming directly to the scene and only be C1 and C2 should go directly to the scene, everyone else needs to go directly to the firehouse. This needs to be discussed at the next Bureau of Fire Operations Meeting. Commissioner Buckley stated that there is a district GOG on this.

- First Aid Supplies:

- o Commissioner Vatter said that Station 37 had a drill and went through all their first aid supplies. He sent Commissioner Nuara a list of inventory that is needed for Station 37. He said that a lot of items are damaged or out of date. Commissioner Vatter gave the Commissioners a copy of the list.
- o Commissioner Nuara brought up the liability of firefighters using first aid supplies and Commissioner Vatter mentioned that every one of the Hillsborough Fire Departments has an EMT/Firefighter Member that could use them.
- o Commissioner Nuara stated that he does not want to have C-Collars, and said that we do not want to start anything to do with Fire Aid, they should not be on our apparatus for liability reasons. Chief Fire Marshal Weniger asked who needs these supplies. Deputy Chief Shaffer will get together with Chief Fire Marshal Weniger to discuss this further.
