RESOLUTION 20-027-Amended

Authorizing Advertisement for Fire Truck Chassis

WHEREAS, The Hillsborough Township Board of Fire Commissioners in the Township of Hillsborough, County of Somerset have approved the specifications for and have determined that they will advertise for sealed bids for Fire Truck Chassis, hereinafter referred to as "Fire Truck Chassis".

NOW, THEREFORE, be it RESOLVED by the Hillsborough Township Board of Fire Commissioners in the Township of Hillsborough, County of Somerset, as follows:

- (1) Specifications are hereby approved and incorporated herein by reference.
- (2) Bids to be submitted shall fully comply with the specifications.
- (3) The Commissioners shall advertise for the receipt of sealed bids for the above named purpose or project.
- (4) Each bid shall be submitted as a written proposal in the manner designated in the instructions to bidders and the specification and shall be signed by the Bidder. The bid shall be enclosed in a sealed envelope bearing the name and address of the bidder on the outside, specifically denoting on said envelope the name of the job for which said bid is submitted and addressed to Hillsborough Board of Fire Commissioners, 379 South Branch Road, Hillsborough NJ 08844.
- (4) The Specifications, instructions to bidders and related documents are on file at the Hillsborough Bureau of Fire Safety Township of Hillsborough, County of Somerset, and may be obtained at the Hillsborough Twp. Fire Safety Office, 379 South Branch Road, Hillsborough, New Jersey, during regular business hours or by calling 908-369-4313 ext. 178.
- (6) Sealed bids shall be called for and shall be received, open and read in public at the Hillsborough Municipal Building, Fire

Safety Office, 379 South Branch Rd., Hillsborough, New Jersey, at 4:00 p.m., prevailing time on **Tuesday January 6, 2021.**

(7) Each sealed bid shall be hand delivered to the Hillsborough Bureau of Fire Safety. **NO BID SHALL BE DELIVERED OR ACCEPTED AFTER THE DATE OR HOUR AS DESIGNATED IN THIS PUBLIC NOTICE. Bids shall be awarded on February 18, 2021.**

(8) The bid quote shall be net to the Commissioners and shall be excluded from any state and federal taxes. The contract will be awarded to the lowest, qualified, responsible bidder. The Commissioners reserve the right to reject any and all bids. The Commissioners also reserve the right to waive any insubstantial irregularities in any bid. The lowest, qualified, responsible bidder will be determined by the Commissioners by examining the price quote as provided for the equipment together with price quote for the extra equipment/accessories and price deductions for deletion of equipment/accessories as specified, if any. The Commissioners reserve the right to award a contract including or deleting any of the equipment/accessories as they may deem necessary in their discretion. When applicable, the bidder must provide a price quote for all extra equipment and price deductions for equipment/accessories as specified. Failure to provide price quotes/deductions for any of these items may result in automatic rejection of the bid.

(1)A Non Collusion affidavit in the usual form will be supplied with the specifications. It shall be executed by the person or corporate officers submitting the bid. A non-collusion affidavit must accompany each bid. Said affidavit must be properly notarized. REQUIREMENT WILL NOT BE WAIVED.

(1)An owner's list in accordance with P.L. 1977, Ch.33, approved March 8, 1977, will also be supplied with the specifications in the usual form. It shall be completed by the person or

corporate officers submitting the bid. Said owner's list must accompany each bid. THIS REQUIREMENT WILL NOT BE WAIVED.

- (12) Bidders are required to comply with the applicable statutory requirement and regulations adopted pursuant thereto, including but not limited to P.L. 1975, Ch.127; P.L. 1977, Ch.33, P.L.1963, Ch.150; and P.L.1933, Ch.277; including all amendments thereto.
- (13) No bidders may withdraw his proposal for a period of 60 days after the opening of bids; all proposal being binding upon all bidders for said 60 day period.
